These are just a few of the dozens of articles that I have read in the recent weeks, as you can imagine the common thread in all of them is the Postal Services financial problems. I have heard several Postal Employees, from Management to the Carriers, saying we have been hearing this for years, and just don't believe that it is important. Or many just don't know what is going on at all because "they don't follow all of that political stuff". But the fact of the matter is, we are in a fight for our jobs, for the continuation of the service that we as Postal Workers provide, and for our customers. The possibility of a disruption or the shuttering of the Postal Service is real and at our doors.

HR 6800, also known as the Heroes Act, was introduced on May 12, 2020, and passed in the House May 15, 2020, 208 to 199. On May 21,2020, this bill was read into the Senate and placed on the calendar for the week of May 25, 2020. If passed into law this bill would provide the Postal Service \$25 Billion in relief funds.

This bill passed through the House by a slim margin, and now it seems that getting it through the Senate and signed into law by the President is going to be an uphill climb.
