



SUBJECT: Announcing Bidding Rights for RCRs

A new Memorandum of Understanding was signed between the National Rural Letter Carriers' Association and the United States Postal Service, which will afford bidding rights of vacant routes to RCRs. The task of drawing up this proposal was assigned to the National Joint Steering Committee of the Quality Work Life/Employee Involvement, who presented this proposal to the National Rural Letter Carriers' Association and the United States Postal Service for adoption. The Memorandum of Understanding has been made a part of Article 12, Section 3, Subsection B of the National Agreement. This Memorandum of Understanding went into effect on November 12, 1986.

The new Memorandum of Understanding provides that Rural Carrier Relief (RCR) employees, who qualify, will be changed to Rural Carrier Associate (RCA) employees. RCA employees will have bidding rights for vacant full time routes. Bidding rights are as follows:

Applicant A

RCR selected from a competitive register in 1981 (during transition period.

• RCRs presents themselves to management as qualified. If eligible will be reassigned as RCA effective April 11, 1987.

• Employee will be immediately eligible for bidding rights.

Applicant B

RCR with 3 years of service as of April 1, 1986.

- Will be offered test familiarization training and will be scheduled for noncompetitive examination.
- If receives passing score, will be converted to RCA effective April 11, 1987.
- Will be eligible to bid following one (1) year of continuous service.

• Applicant continues to remain eligible for residual rural carrier vacancies for any register they have eligibility if opportunity arises before bidding rights begin.

Applicant C

RCR with 3 years of service as of April 1, 1987.

- Will be offered test familiarization training and will be scheduled for examination.
- If RCR declines opportunity, or fails to receive passing score, will remain on the rolls as an RCR. Applicant D

RCR with less than 3 years of Service as of April 1, 1987

- Will be offered test familiarization training and will be scheduled for examination for RCA register under delayed procedures.
- If receive passing score (70 or above) rating will be merged with newly designated RCA register. Scores will remain on the register for consideration for full time rural carrier.
- If score is reached, will be converted to either an RCA or full time rural carrier if appropriate.

RCRs, in all categories listed, are not required to take the examination if they have already taken and passed it. However, you may wish to retake the exam to receive a higher score.

The National Rural Letter Carriers' Association has the exclusive right to represent rural craft employees of the Postal Service. Therefore, we would like you to become a member of the National Rural Letter Carriers' Association. This will also entitle you to membership in the State Association as well.

Membership dues for an RCR working in <u>Washington</u> are \$ 36.00 per year. To join, please send your membership payment, along with the enclosed application form, to me. I will forward the national portion of your dues to the National office.

Membership in this Association will entitle you to a free subscription to our weekly publication, The National Rural Letter Carrier, which will keep you informed of all the current issues concerning rural carriers. You will also be eligible to participate in the Associate Hospital Plan Health Insurance and the Auto-Homeowners Insurance Plans. Enclosed is a list of reasons why you should join this Association. The current agreement with the Postal Service allows for annual pay increases for RCRs, and it give RCRs, access to the grievance-arbitration process. You may no longer be disciplined without cause.

WHY SHOULD RCR'S JOIN?

- Bidding rights according to the Memorandum of Understanding signed November 12, 1986. A change for RCRs to become regular carriers.
- 2. RCR employees do receive the contractual pay increases in basic salary as do all other employees.
- 3. RCR's receive training pay.
- 4. If the RCR is selected by the rural carrier, the RCR cannot be forced to serve the second or third route and will not be dismissed for same. If management selects the RCR the RCR can be utilized on one, but not more than three routes and can be dismissed for not carrying the routes management has assigned them to carry.
- RCR employees have the protection of the Association's National Agreement, except where prohibited.
- 6. RCR's are entitled to relief days when serving on a vacant J or K route if requested or required by local management.
- 7. Many become eligible for vacant routes by competing competatively on an open examination. If they make the top 3 of the register they are given preference subject to veterans' preference statues.
- 8. Receive the NRLCA magazine about 47 times a year to keep them informed on the issues.
- 9. As a member they are entitled to all the benefits of being a delegate, officer, steward and voting member on issues, inc.
- 10. Entitled to the Associate Hospital Insurance Plan, and the Auto-Homeowners Insurance Plans.
- 11. Covered by the Federal Employees' Compensation Act and Tort Claims.
- 12. Draw the evaluated pay of the route even if they don't work the full evaluated time of the route that day.
- 13. Draw overtime pay for all hours worked in excess of 40 hours in one week.
- They will have seniority for the purposes of assignment to an auxiliary route in the office.
- Will continue to be the sub for the regular carrier when analgued to an auxiliary route, thereby maintaining the maximum income for the job.
- If regular carrier transfers to another route, RCR can transfer also, provided there is not a sub or RCR already assigned to the route.

I would like to wish you the best in this New Year, 1987, and hope it will be prosperous for each carrier and our organization. In our area the mail seemed to flow smoothly at Christmas time. There was more than we liked, yet I have not heard many complaints.

Here are some dates to remember:

District III Meeting March 8th
District IV Meeting March 15th
District I Meeting March 22nd
District II Meeting March 29th

Come to your District Meeting and meet your State Officers.

Western States Conference in Mesa, Arizona - April 24th and 25th. I have the cards that are required for registration at the Motel. Call or write and I will send you one.

State Convention - June 21st - 24th, Spokane, WA. More information will follow.

As most of you know from reading the National Magazine, there are some new things for the RCR's. Starting the first of the year and before the 1st of April they will be given an opportunity to take either a non-competitive or a competitive test, depending on the time they have been employed. This will lead to bidding rights for regular carrier status on routes. Those that were changed to RCR's because they were in the "transition period" at the time the 1981 agreement was signed can take the test and have bidding rights effective April 11, 1987. Those who started before April 1, 1984 have their bidding rights delayed one year. These first two groups of employees will be able to take a non-competitive test. Those with less than three years service will be able to have a delayed application. These scores would then be merged with the register for the office where they are employed, and if that office is part of an area register, the RCA would also be eligible to be considered at all offices within the area register. This is not all we want in this area, but it is a step forward. Some new areas that came from the time study allowances required by Volz arbitration award are:

- 1. The 82% coverage factor will only apply to Regular boxes, with Centralized boxes being credited at one minute each.
- 2. That when an 'L' Route density drops below 12 boxes per mile, it will be returned to the regular route status determined by the evaluated time for the route. The mail count to be conducted in August and September, 1987, will be the initial evaluation for this route.
- 3. Auxiliary routes will be compensated on the daily evaluated hours of the route. This will not change the overtime requirements as it changes from actual hours to evaluated hours. Overtime will be paid for any hours in excess of 40 hours per week. These changes will not take effect until November 7, 1987.

As some of you know, our election at last year's convention was challenged. This is the result of the investigation by the Department of Labor.

1. State Association Officers were elected by delegates not all of whom were elected by secret ballot as required by LMRDA 401 (E). A secret ballot is defined as follows: The expression by ballot, voting machine, or otherwise, but in no

event by proxy of a choice with respect to any election or vote-cast in such manner that the person expressing such choice cannot be identified with the choice expressed. To secure such secrecy at the polls, a union should provide such facilities as curtains, screens, partitions, separate rooms, booths or a separate voting area. The union is responsible to see that votes are cast in private. I don't believe any county unit voted this way and because our constitution and by-laws prescribe this method in our state elections, this would have to be done in all contested state elections. This was not done because we were ignorant of this law. An uncontested election would not require a secret vote and could be by motion to have the chairman cast a unanimous ballot.

- 2. Notice of delegate elections must be made 15 days in advance of the nominations and elections LMRDA 401 (E). This also was not done in all county units or the state election.
- 3. Records pertaining to State Association Officer nominations were not maintained as defined by LMRDA, Sections 401 (E) and (F). All election records must be kept for one (1) year. The ballots were destroyed following the 1986 convention because of a motion and delegate vote.
- 4. Union funds were used to promote the candidacy of an officer candidate position. This was using state funds for a candidate even though it was done without knowledge of this law.

This was the result of the investigation. I am sorry I didn't have this knowledge before and I was told we always did it this way. I have now signed a letter to the Secretary of Labor giving them the right to supervise this year's delegate and state Officers elections. They also have the authority to decide any questions pertaining to the election of delegates and officer elections. This letter binds the National Association and the State Association of the Rural Carriers to this agreement. As I said, I am sorry this happened, but it has been and will be an education in Union elections.



There are a lot of changes in the Postal Service this year. We have a new Postmaster General, Preston R. Tisch. We also have a new Chairman of the Board of Governors. The Board elected John N. Griesemer to take the place of John R. McKean. These gentlement should settle the Postal Service to a more moderate executive panel. 


We are well into 1987 and we are all making plans for the year. At this time I would like to ask District IV mem-

Promises, Promises, seems that's all I do when it comes to Quality of Work Life/Employee Involvement. Here comes one more; it's getting closer! The goal is to start in Washington in March. I have been called to San Francisco the last week of January for Q.W.L. training.

The January 19th Federal Times reporting on Postmaster General Tisch's comments to the Board of Governors says that the Postmaster General reported that progress has been made in getting Postal Unions involved in the Quality of Work Life Program.

Postmaster General Tisch singled out the National Rural Letter Carriers' Association for special praise for its contributions to the program.

Just between you and me, the Rural Carrier work system lends itself to accommodating the process easier than the other crafts.

SAFETY

I keep hearing of Rural Carriers that are being told that their tires are worn out and need replacing. Come on people, it is winter time. No one who makes his or her living as a Rural Carrier driving winter roads has any business running on worn out tires. The <u>best</u> tires are none too good this time of year.

Our craft has been due some good news and finally we seem to be getting some:

- 1. The National Quality of Work Life was able to get the RCR-RCA program negotiated between contracts. This RCA conversion is really good news. It will give our RCR priority bidding rights and should go a long way towards stopping the turnover in the RCR ranks.
- 2. After September 1987 Mail Count cluster boxes will be worth 1 minute to L-Route carriers as well as others.
- 3. After the September 1987 mail count L-Routes will be allowed to flip flop. That is if the count shows the route again has a density of less than 12 boxes per mile on an average, the route will be classified NON-L again.

FROM YOUR STATE STEWARD (CONT.)

- 4. Auxiliary routes will pay the evaluation, the same as regular rural routes. This is good for some, bad for some, but should be more good than bad.
- 5. RCR training to be done so as to comply with P-23 handbook.

The calendar is fast filling up with meetings, hope to see you at one of them.

I hope each of you are trying to make a few small items for our Country Store this year. This keeps our scholarship growing.






