The Washington Rural Letter Carriers' Association is pleased to present Susie Hill as the 2006-2007 Member of the Year. Facilitator for the Quality of Work-Life/Employee Involvement (QWL/EI) process and as Recorder for the Seattle District Joint Steering Committee.

Susie has served her community (and her children) as a Cub Scout leader, Brownie Leader and as the High School Tennis Team fundraising Chair-person for both Wes and Adriane.

Years ago Susie received a teaching certificate from Western and can teach us all a little something about "Service with a Smile." Loved, respected, admired and nominated by her peers, Susie Hill is truly the "Outstanding Member of the Year."

PRESIDEN'S REPORT FOR 2007 CONVENTION PATRICIA ALEXANDER

I have attended all meetings required by my position as President. I have presided at the Board meetings, and I have attended



the Presidents' and Vice Presidents' Legislative Seminar where Vice President Patrick Pitts, State Steward Charles Alexander, and I voiced our concerns to our legislators about Contract Delivery Service. Our legislators and/or their staff understand that CDS would be the end of rural and city delivery, and when I emailed thank you letters to each member of Congress, letting them know how much rural carriers appreciate their support against CDS, I received positive responses and even dismay that the Postal Service is trying to save money by discontinuing benefits for its employees. Senator Patty Murray's father was a veteran of World War II and was in a

wheelchair when he came home from the war. When I mentioned to Senator Murray's staff member that there would be no more Veterans' Preference in hiring if CDS is not stopped, she was adamant that CDS is not the proper avenue for delivering the mail. I will continue writing to Congress until CDS is stopped, and I hope all of you will also write to your representatives in Congress.

Each day, I answer telephone calls and email, and when I am away, I have my laptop to keep in touch with Washington rural carriers. I also write letters of encouragement to rural carriers who are having bad times in their office or in their home. We are all a family, and we need to keep in touch.

I continue to serve on the National Joint Steering Committee for Quality of Worklife/Employee Involvement. I have heard some rural carriers say that QWL/EI is no longer working, and that the Postal Service is not sincere in wanting to work with rural carriers for the betterment of the Postal Service and for the betterment of rural carriers. In some instances, this may be true, but we have to keep trying to work together. Think of all that our work teams have been able to accomplish: the orange stamp envelopes, notices of our services for our customers, hiring and retention projects, and the list goes on and on. We should take great pride in working together to improve our workplace environment, and I hope that all of you have had a chance to look at the new safety booklet, "Lifting the Fog," a project that began with a work team and was picked up by the Headquarters Safety Team, reviewed by the NJSC members, and is now supposed to be at every rural carrier's case. Please let me know if you do not have a copy of "Lifting the Fog," as you will want to see the photographs of actual accidents and read the true stories of rural carriers who survived because they were wearing seatbelts and were very lucky. Managers are supposed to be using "Lifting the Fog" in Safety Talks and for Voice of the Employee talks.

It is interesting to note that even after our contract

ratification was voted down, NJSC meetings continued, and the same people who are doing contract negotiations are on the NJSC: Bill Daigneault and Bob West for the Postal Service, and President Donnie Pitts and Vice President Don Cantriel for the National Rural Letter Carriers' Association. The other two rural carrier members are Oklahoma State Steward Gil Sreaves and me. We are all team members, but we also always remember that the Postal Service members are managers with vested interests, and we rural carriers are there to help protect your interests while trying to work together.

The other National Committee that I am on is the Constitution and Bylaws Review Committee. We have met at least once a month for the past year, looking at our National Constitution and working to make it one instrument that is easy to understand and read. The delegates to this year's National Convention in Grand Rapids, Michigan, will be voting on this new Constitution, and all delegates will be given a copy at their respective State Conventions so that every delegate will have a chance to review the document and be ready to discuss and vote on the Revision. This new National Constitution will be the first item presented by the Constitution and Bylaws Committee. Members of the Constitution and Bylaws Review Committee will begin work on August 3, 2007, as every Constitution and Bylaws sent by the states will need to be ready to be presented to the delegates, and since we do not know if the new Constitution will be accepted, each Constitution and Bylaws will have to be ready in two ways: with the old Constitution and Bylaws as it is written now, and with the new Constitution that we hope will be passed by the delegates. The Review Committee will be working closely with the Constitution and Bylaws Committee, and we are hoping that the hotel at the National Convention will have adjoining rooms for us.

This has been an interesting project, and we hope that every delegate will see that the new instrument is almost exactly the same as the old Constitution and Bylaws, except that the new Constitution is easier to read and is now one Constitution, rather than a Constitution and a Bylaws section. Should this new Constitution be passed, there would be no change in the way this Association is run. We are hoping that there will be no substantive amendments to the new Constitution, and that it will simply be passed. After that, amendments can be presented if delegates wish.


After the Constitution is accepted by the delegates, then our next task is to work on State Constitution and Bylaws to be sure they are in compliance with the Department of Labor, the Internal Revenue Service, and the National Constitution and Bylaws. We will look at the Constitutions and Bylaws of the committee members first, and then we will look at other states. Our suggestions will be given to the National officers who will then talk with State officers if necessary. Some State Presidents have approached me at meetings. wanting to know if this means that all States must have the exact same Constitution and Bylaws, and I have assured them that we understand States' Rights and autonomy. Our concern is that DOL and IRS rules be followed to keep all of us out of trouble.

It is a pleasure to be on this committee and to try to make our National Constitution easier to read and understand. We also hope that it will be easier to find subjects of interest.

Most important of all, though, is our hard work to stop Contract Delivery Service. The Postal Service is changing, and we understand that cost effectiveness is necessary, but it is criminal to have a work force without benefits. We must protect our jobs for those who follow us. Contracting out delivery is not the best way to save money.

VICE-PRESIDENT'S REPORT FOR THE 2007 STATE CONVENTION PATRICK PITTS

It has been an interesting year for members of the Rural Craft in Washington State. Before addressing issues of concern, allow me a moment to take care of formalities. During the 2006/2007 Association year I have attended



all meetings and fulfilled all responsibilities associated with the office of Vice-President of the Washington Rural Letter Carriers' Association (WARLCA). In addition to attending and participating in all WARLCA Board meetings I attended all District meetings and as many County meetings as I was able.

I'm pleased to announce that we have seen an increase in attendance over the last year at nearly all meetings at the County level. Your County officers have worked diligently at increasing participation by members and are to be commended for their efforts. A two-fold challenge was presented to your County officers at the onset of the 2006/2007 Association year. County officers were challenged to; increase participation at local meetings and increase attendance at the State Convention. As of the writing of this report we have, approximately, a 23% increase in the number of Delegates to State Convention (as compared to the 2006 State Convention) and a record number of Delegates attending for the first time. Again, we should all give a huge "pat on the back" and a "job well done" to our County officers.

During the 2006/2007 Association year I attended various meetings at the District level including; a number of Labor/Management informational meetings, an Employee Assistance Program (EAP) Advisory Committee meeting and a Voluntary Protection Program (VPP) meeting. (VPP is an Occupational Safety and Health Administration

(OSHA) program recognizing worksites that implement exemplary systems to manage worker safety and health.) I also attended the National Presidents/Vice-Presidents Legislative Seminar held in Washington DC petitioning members of the House and Senate to support legislation which would serve to protect members of the Rural Craft and/or further their interests. Additionally, I attended and provided written testimony to a hearing of the Washington State Senate Committee on Housing and Consumer Protection opposing the implementation of a "Do Not Mail" registry in our State.

During the 2006/2007 Association year we have seen the expiration of our Agreement (Contract) with the Postal Service and a proposed Agreement presented to the membership for ratification. As most of you are aware, the proposed Agreement was not ratified, with only approximately 40% of those entitled to vote taking the time to do so. As of the writing of this report negotiations are ongoing with a strong likelihood that impasse will be declared and the matter being scheduled for Arbitration.

Also during the last year we have seen a concerted drive by the Postal Service to promote and implement the use of contract carriers to deliver the mail in what otherwise would be rural or city territory. Contract Delivery Service (CDS) is arguably the greatest single threat to the Rural Craft in recent memory. Your State and National Association is addressing this growing threat on every front and with every resource available. Never before has it been more important for every member of our Craft to become involved, to link arms and stand firm against this assault on the employees entrusted with the safe, secure and timely delivery of the Nations mail. Failure to do so could very well result in the demise of the Postal Service, and the Rural Craft as we know it.

As stated at the opening of this report, it has been an interesting year for members of the Rural Craft in Washington State. It has been a pleasure serving you. A heart-felt "thank you" to the members of the WARLCA State Board, County Officers, Stewards and Members of the State Association. As always, I welcome your questions, comments and expressions of concern.

DISTRICT ONE REPORT FOR THE 2007 STATE CONVENTION BECKY PIKE

SECRETARY-TREASURER'S REPORT FOR 2007 STATE CONVENTION REBECCA WENDLANDT

Hello Fellow Members of the WARLCA and Honored Guests:

MEMBERSHIP:

I sent in 244 membership applications in the 06/07 year as of May 31, 2007. This does not reflect the 28 cash members that have renewed for 07/08 so far. In 06/07 as of May 31, 2007, we have had 11 cancel their dues, 22 deceased, and 141 separated. I have done one complete mailing for all 609 non members (216 regulars, 8 PTF, 385 reliefs), as well as quarterly recruitment mailings for all new hires (around 90 per quarter). I did one special mailing to all 385 relief non members about the relief carriers' health insurance available through YOUR union. We



have decreased our non member totals by 100 from last year and increased our member totals by 101 members to 1938 (last year at this time we had 1837, including associates). Here are some membership stats:



STATE STEWARD'S REPORT FOR THE 2007 STATE CONVENTION CHARLES ALEXANDER

THE 100-YEAR ISSUE WE CANNOT IGNORE

Like the major floods, earthquakes, or hurricanes that only come around, on average, every 100 years, the two delivery crafts (rural and city) are currently facing what I do not



hesitate to call the most significant attack by the Postal Service against the very nature of our continued existence. What's at stake is all new delivery, other than fill in, which Postal Service Headquarters has ordered the field to place on Contract Delivery Service (CDS) routes. On March 17, 2007, I sent out the first in a series of emails referencing "The War Against CDS." From what has happened since that email went out, it is apparent that the warning signs and the threats to the delivery crafts were real. That March 17 email stated the following:

"The next big fight to protect the jobs and careers of both present and future mail carriers has already begun. The two attached files describe in published articles how the Postal Service is attempting to save money by creating virtual employees without benefits. Unwitting low bidders are seeking to go into the mail delivery business and ostensibly provide the same service as their rural and city carrier counterparts.

Rural craft stewards in States throughout the Country have been filing and winning grievances against the Postal Service for pursuing a USPS Headquarters' Policy of establishing all new rural and city delivery, expected to culminate at four hours per day or more of evaluation, as Contract Delivery Service. Make no mistake, the Postal Service has seriously begun a policy of delivery

privatization.

From the following Arizona email sent from a District-level manager to managers in the field, the Postal Service's intentions are perfectly clear:

We had a 2 hour telecom today with Western Area and HQ regarding CDS (contract delivery service) routes. The key points are:

- 1. It's not an option and we need to put in CDS everywhere practicable.
- 2. In short, we can put in CDS anywhere that the workload will be 4 hours or more. We can put in a CDS route in the middle of downtown Phoenix if we choose as long as it's 4 hours and was not already delivered by a city or rural route.
- 3. There is no longer an interpretation or position that we cannot put in CDS where a new development is surrounded by rural or city delivery. The ONLY criteria is that the new territory must be 4 hours of work per day. The 4 hours must happen within 12 months if it otherwise would have been a rural route, but where it otherwise would have been a city route, the criteria is the 4 hours must happen when the development is done.
- 4. Where you have an agreement between USPS and the unions establishing delivery boundaries, they do not apply to CDS. If the agreement is not signed by a USPS management person, then it is not binding. If you have been managing to a written agreement that is not signed by management or a verbal agreement, neither of them are binding and past practice does not apply. You can put in any type route in these situations based on best needs of the service.
- 5. HQ is nearly finished with the new forms and tools for managing CDS routes.
- 6. New Growth Management tool will be done soon and will encourage us to use the most cost effective delivery method by forcing us to explain any non-CDS deliveries. In short, when this tool is done all growth as far as assigning to a delivery route or mode will be controlled at the district level.
- 7. When starting delivery, you can have a casual or RCA deliver the route until a contract is awarded. There is not a place to transfer the hours for a casual or RCA when they carry a CDS route. HQ

is discussing this issue.

We will have to fight back with every legal means available, or the recent record growth in the rural craft will surely take a dramatic downturn. One of the best means available to push back against privatization of the Postal Service is to let your Senators and Congress Representative know what the Postal Service is up to and what you think about the initiative to put CDS everywhere possible. The NRLCA National Board has already put CDS at the top of our legislative lobbying agenda for 2007. In a similar manner, the NALC (City Carriers) and both Postmaster Associations have tagged CDS as fertile ground for a strong lobbying effort.

There are few things more effective than a sincere and widespread grassroots letter-writing campaign, so I urge each and every one of you to take up the challenge and write to your National Congressional Representatives about the Postal Service's objective to privatize a significant portion of the rural craft. The two attached files contain many good arguments ripe for the picking. Form letters are not nearly so effective as individually typed or penned correspondence, so please, double please, write to your Representatives and put the pressure where it will be felt. We cannot afford to wait."

I sent out 104 email updates this past Association year, but no issue was/is more important than the battle to stop CDS. Since I sent the March 17, 2007, email above, multiple offices in our State have announced or initiated CDS routes. We have grieved, and will continue to grieve, each and every attempt by management to assign new territory, surrounded by or adjacent to rural delivery, to CDS.

Meanwhile, at the urging of me and many others, your National Board, through President Donnie Pitts, has filed two grievances against CDS. Simultaneously, the NRLCA is working closely with the NALC City Carrier Union to develop joint strategies to combat the Postal Service's aggressive CDS initiative.

Most important of all, we need to continue to solicit help from the United States Congress to force the Postal Service to abandon their plans to privatize delivery. With the introduction of Senate Bill 1457 (The Mail Delivery Protection Act of 2007) by Iowa Senator Harkin, we have reason to be optimistic, but no excuse for being complacent. We need co-signers for the Harkin Bill in the Senate and the introduction of a similar bill in the House. The current House Resolution 282 is a good start, but its language is too broad, and it is not a bill. Even if you hate politics or have never written to your Representatives or Senators, now is the time for your 100-year letters. Nothing short of the continued existence of our craft is on the line.

GRIEVANCE STATISTICS

The total of all post offices and branches in Washington State is approximately 237. Of those 237 units, 23, or roughly 10%, had grievances filed that went to Step 2 or higher in the 2006-2007 year, 2% less than last year.

It is important to remember that the above totals are only for grievances that were appealed to Step 2 of the grievance process. I do not track the grievances that are settled or withdrawn at Step 1, but I think it would be a fair estimate to state that there are at least as many grievances dispensed with at Step 1 as there are that have to go to Step 2 or beyond. The great majority of these "hidden" grievances are processed and resolved by Local Stewards, and whenever this is the case, the Postal Service picks up the bill for the Steward Time. If your office is fortunate enough to have a Union member volunteer to stand for election to fulfill the duties and responsibilities of Local Steward, the rest of you should be supportive and appreciative.

The most frequent reason I hear that Local Stewards give up their position is that they just don't want to put up with the grief that comes their way from their fellow rural craft employees. That's a sad state of affairs, indeed, when carriers prefer to abuse their Local Stewards, rather than address their issues with management directly.

The numbers for each of the categories for this

In addition, there was 1 Labor Charge filed against the WARLCA by a non-member, but the Department of Labor refused to issue a complaint, because the investigation did not reveal that the Union failed to meet its duty of fair representation.

Notable from the above data is the two-fold increase in Step 2 denials and 3 fewer Step 2 settlements, compared to the same period last year. It is my opinion that the downturn in resolution of grievances at Step 2 was due mainly to the Seattle District's Step 2 Designee's reluctance to independently render decisions in opposition to the hard-line positions of some of the District staff in Operations Programs Support. This theory is further supported by the nearly 50% increase in the number of denied Step 2 grievances which were settled in the Union's favor at Step 3. The number of grievances appealed to Step 3 held constant at 12, the same as for the last two years.

The Steward System's unofficial motto remains unchanged: Our strength is in our openness to work together with management when mutual benefit is possible, and teamwork to stay the course when the going gets rough.

2007 Convention Standing Rules

- 1. Each session shall start at the time announced in the convention program.
- 2. The convention shall proceed using Roberts Rules of Order, Newly Revised (10th Edition).
- 3. Voting on specific issues shall be by the use of "yea" and "nay" cards.
- 4. Non-delegates may be recognized and allowed to speak at the discretion of the Chair.

- 5. Only duly elected and seated delegates shall be allowed to vote on issues before the convention delegates.
- 6. Before a member can make a motion or address the convention, the member must rise and be recognized by the Chair, state his/her name, whether a delegate or a non-delegate, and his/her county affiliation.
- Resolutions shall be read, and if no objection is voiced, they shall be considered passed at the sound of the gavel by the Chair.
- 8. All resolutions objected to shall be brought before the delegates for consideration after all resolutions have been presented.
- Resolutions not passed at the first reading shall be presented to the delegation for consideration. The delegate who objected to the resolution shall be allowed to present his/her argument or call for clarification at the second reading. The delegate-at-large for the county of origin or a designee shall be allowed to present the first arguments for the resolution.
- 10. During the second reading of resolutions, the time limit for consideration shall not exceed 10 minutes, including all amendments to the resolution, unless extended by a majority vote of the delegates.
- 11. During the consideration of resolutions at the second reading, the con and pro shall alternate with a 2-minute time-limit per person.
- 12. Delegates shall be allowed to speak no more than twice on any particular issue.
- 13. If there is no opposing position to be presented, the resolution shall be brought to an immediate vote of the delegates.
- 14. Campaign materials may only be distributed at or near the entrance of the convention floor.
- 15. The reports of the Officers of the WARLCA shall not be read to the delegation. Time shall be set aside for a question and answer period to be held the afternoon of the first day of convention. Reports will be available for dissemination during the morning session of the first day of convention.
- 16. These rules shall be in force throughout the convention unless amended by a two-thirds vote of the delegates.

Janie Walla made a motion to dismiss the Mileage and Per Diem committee with our thanks. The motion passed.

President Alexander asked for the Final Report of the Constitution and Bylaws Committee. Chair Renee' Cowan came forward and re-introduced the committee.

Proposed Constitution and Bylaws Changes

(Bold print is new and amended language, underlined is language that was proposed to be deleted but voted to be kept, and lined-out print is removed language. Only the proposed language is printed here along with the dispensation of the proposed constitution and bylaw.)

1. From East Central Washington County: Found in 06/07 Constitution, Article IX (National Delegates), Section 9.

Proposed Language:

SECTION 9: The WARLCA will pay all regular credentialed delegates to National Convention that are not reimbursed by National, the same way and rate that National reimburses, up to a total dollar cap decided by the WARLCA board at the first board meeting of the year. If the reimbursement amount exceeds the set total dollar cap, each delegates' reimbursement will be reduced by an equal percentage to comply with the cap. Further, all regular credential State-paid delegates to the National Convention must attend all business sessions, Western State caucus, and at least one seminar. If a State-paid delegate does not meet his/her delegate's responsibilities, the remainder of the WARLCA delegates will decide before the end of the National Convention and before receiving the reimbursement if that delegate is to receive all or any of the State-paid funds due to not meeting his/her responsibilities. To qualify to receive reimbursement from the State as a regular delegate to National Convention, the member must also have been a county credentialed delegate to at least one State Convention in the preceding two years.

Tony Lott made a motion to accept this proposed constitution and bylaw change. Motion Failed. Note: After President Patricia called the meeting to order on Saturday morning, Donna Roakes made a motion to reconsider this proposed constitution and bylaw change. Motion passed. Donna Roakes made a motion to divide this proposed constitution and bylaw change. Motion passed. Donna Roakes made a motion to postpone indefinitely the underlined language in section one of this divided proposed constitution and bylaw change. Motion passed. Donna Roakes made a motion to delete the strikethrough language in section two of this divided proposed constitution and bylaw. Motion passed.

The meeting was adjourned at 4:30 PM.

Saturday, June 16, 2007

President Alexander called the meeting to order at 8:00 a.m. Secretary-Treasurer Becky Wendlandt read roll call and distributed the Yea/Nay cards. All officers except Retired Representative Ed Koschalk, and delegates were present.

Donna Felgenhauer, WARLCA Auxiliary Secretary-Treasurer reported on the scholarships. Donna said 13 applications were requested that she sent out and 8 came back for the State and 6 for National. Scholarships were given to:

\$500 to Anna Pilon, Lynden, WA

\$300 to Jacob Sitton, St. John, WA

The name for the Gene Del Polito scholarship that was sent to National was Michael J. Lundy of Spokane. Joe Horlacher, WARLCA Auxiliary President thanked the association and LeAnn Cook made a presentation to Neil and Myrtle Buchanan for their 41 years of work with the WARLCA. **Myrtle was picked as Member of the Year for the WARLCA Auxiliary.**

Over \$400 was collected for Nicole Cowan to attend National Convention and run for office.

President Alexander called for the Final Report of the Constitution and Bylaw Committee to be continued.

Proposed Constitution and Bylaw number one was reconsidered (see notes above)

2. From East Central Washington: Found in 06/07 Bylaws, Article V (Editor), Section 1. Proposed Language:

SECTION 1: The Editor shall publish five (5) three (3) issues of the WASHINGTON RURAL CARRIER. The State Board shall have the authority to authorize special editions. Also, the State Board shall have the authority to identify which articles and notices will be published in each issue, and to determine and change issue dates as current events may require.

Mariann Faulkner made a motion to accept this proposed constitution and bylaw change. Donna Roakes made a motion to amend language; to change 3 issues to 4 issues. Amendment Failed. Motion passed.

3. From King Snohomish: Found in 06/07 Bylaws, Article VII (Revenues and Dues), Section 4. Proposed Language to be inserted:

The Auxiliary will fund a junior representative to attend National Convention. The auxiliary will pay the junior representative the same way and rate that the WARLCA pays all regular credentialed delegates to National Convention. If, however, the junior representative is traveling with a parent who is a paid delegate, the junior representative shall be paid the mileage portion of the National Delegate compensation. The junior representative will be selected at the close of State Convention by the incoming Auxiliary Board with primary consideration given to junior officers.

Renee' Cowan reported that the Constitution and Bylaws committee felt this was out of order. President Patricia ruled that this proposed constitution and bylaws change was out of order.

4. From Yakima Valley County: Found in 06/07 Bylaws, Article X, Section 1 (Districts and Counties)

Proposed Language:

DISTRICT FOUR (4) shall be composed of the County Units of: SOUTHEAST WASHINGTON (Walla Walla, Columbia, and Garfield Counties); WHITMAN-ASOTIN (Whitman and Asotin Counties); APPLE VALLEY (Adams, Franklin, Kittitas, Yakima, Benton, and the non-986 offices of Klickitat Counties). Jim Crouse made a motion to accept this constitution and bylaw change proposed change.

Motion passed.

Renee' Cowan made a motion to dismiss the Constitution and Bylaws committee with our thanks. Motion passed.

President Alexander asked for the **Resolutions Committee** to come forward. Chair Jan Frymire introduced the committee.

RESOLUTIONS PASSED AND SUBMITTED BY THE COUNTIES TO THE 2007 WARLCA STATE CONVENTION SPOKANE, WASHINGTON

1. Submitted by North Central Washington: Binding: To the National Board

Be it resolved that the National Board shall have our lawyers create a legally binding release form that will allow officers, and stewards lacking direct steward responsibilities, to discuss problems with our coworkers without putting the Association in jeopardy of a lawsuit.

Jan Frymire made a motion to accept resolution number one. Resolution number one failed.

2. Submitted by Peninsula Counties: Non Binding

Whereas, a continuing primary leave replacement assignment vacancy shall only be offered again when there is a substantial change to the route. Therefore be it resolved a continuing primary leave replacement assignment vacancy shall also be offered after 6 calendar months have passed since the last offering of the vacant assignment for the route.

Carrie Smith made a motion to accept resolution number two. Ann Lamm made a motion to amend resolution number two from 6 calendar months to 4 calendar months. Amendment Failed. Resolution number two passed.

3. Submitted by Peninsula Counties: Non Binding

Whereas rural schedules are generally determined using the evaluated office and route standard times from the route's most recent Form 4241-A. Therefore be it resolved that for carriers choosing to case DPS mail, the evaluated time allowance for DPS letters shall be transferred from standard route time to standard office time for purposes of determining scheduled leaving and return times.

Resolution number three passed with the drop of the gavel.

4. Submitted by Peninsula Counties: Non Binding

Whereas official route mileage accounts for a significant portion of a carrier's compensation with regards to route evaluation and EMA.

Therefore be it resolved that official route mileage shall start at the authorized loading area, proceed following the official line of travel to each active delivery point (to include pulling in and out at each box or authorized dismount point), and end at the authorized unloading area.

Resolution number four passed with the drop of the gavel.

5. Submitted by Peninsula Counties: Non Binding

Whereas regular rural carriers required to work their designated holiday are compensated at the carrier's daily rate of pay (in addition to holiday leave pay) while regular rural carriers required to work their relief day are entitled to compensation up to the equivalent of 150% of the carrier's daily rate of pay. Therefore be it resolved regular rural carriers working their designated holiday shall be compensated at 150% of the carrier's daily rate of pay. Be it further resolved that regular rural carriers working their designated holiday shall be eligible for annual leave earned in lieu of holiday leave pay.

Resolution number five passed with the drop of the gavel.

6. Submitted by Peninsula Counties: Non Binding

Whereas RCA's only earn leave when assigned to auxiliary routes, or as the primary leave replacement on routes vacant over 90 days or when the regular carrier is on extended leave over 90 days.

Therefore be it resolved all RCA's shall earn leave at the same rate as RCA's assigned to auxiliary routes, upon completion of their probationary period.

Cindy Adams made a motion to amend resolution number six to add "SRC's"—Substitute Rural Carriers—after RCA's. Amendment passed. Amended resolution number six failed.

7. Submitted by Peninsula Counties: Non Binding

Present Language: The probationary period for a new employee appointed as a regular rural carrier shall be ninety (90) calendar days. The Employer shall have the right to separate from its employ any probationary employee at any time during the probationary period, and these probationary employees shall not be permitted access to the grievance procedure in relation thereto.

Proposed Language: The probationary period for a new employee appointed as a regular rural carrier shall be ninety (90) calendar days. The Employer shall have the right to separate from its employ any probationary employee at any time during the probationary period, subject to the grievance procedure and in accordance with Article 16 of this agreement.

Jan Frymire made a motion to accept resolution number seven. Resolution number seven failed.

8. Submitted by Peninsula Counties: Non Binding

Present Language: The probationary period for a rural carrier associate shall be 90 days actually worked or one calendar year, whichever comes first. All other applicable provisions of Article 12, Section 1, shall apply. Proposed Language: The probationary period for a rural carrier associate shall be 45 days actually worked, six calendar months, or upon utilization and/or training on a route other than their assigned primary assignment, whichever comes first. All other applicable provisions of Article 12, Section 1, shall apply.

Carrie Smith made a motion to accept resolution number eight. Resolution number eight failed.

9. Submitted by Peninsula Counties: Non Binding

Whereas, Interest is paid automatically for arbitration decisions that award back pay for a disciplinary suspension or removal for employees represented by the National Postal Mail Handlers' Union (NPMHU) for cases heard after February 20, 1991, and for employees represented by the National Association of Letter Carriers (NALC) and the American Postal Workers' Union (APWU) for cases heard after June 12, 1991.

Note: For arbitration decisions that are unrelated to a disciplinary suspension or removal, interest is

not paid unless it is specifically required by the award.

Therefore, be it resolved that interest be paid automatically for arbitration decisions awarding back pay for a disciplinary suspension or removal for employees represented by the National Rural Letter Carriers' Association (NRLCA).

Cindy Koker made a motion to accept resolution number nine. Resolution number nine passed.

10. Submitted by Peninsula Counties: Non Binding

Whereas, In no instance is a rural route on which an employer-provided vehicle increased in weekly evaluation by less than 30 minutes. Note: If the fueling location is not on the carrier's line of travel, use the following formula to compute the daily average deviation and include it in the total route mileage. Fueling mileage deviation times daily route miles times six divided by 100 miles per fueling divided by 6 days equals daily average deviation.

Therefore be in resolved that in no instance is a rural route on which an employer-provided vehicle increased in weekly evaluation by less than 30 minutes. Note: If the fueling location is not on the carrier's line of travel, use the following formula to compute the daily average deviation and include it in the total route mileage. Fueling mileage deviation times daily route miles times six divided by 100 miles per fueling divided by 6 days equals daily average deviation.

Jan Frymire made a motion to accept resolution number ten. Resolution number ten passed.

11. Submitted by Lower Columbia: Non Binding

Whereas EMA is inadequate compensation of POV and delivery of mail from a left hand drive is unsafe, Therefore be it resolved the USPS be required to provide vehicles to all rural routes.

Carrie Smith made a motion to accept resolution number eleven. Jim Hemrich moved to amend resolution number eleven by adding at the end "on which the assigned regular carrier requests them. Tony Lott moved to amend the amendment to take out "regular". The amended amendment passed. The amendment passed. Resolution number eleven as twice amended failed.

12. Submitted by Lower Columbia: Non Binding

Therefore be it resolved that the calculations for EMA be more reflective of the price of fuel. Cindy Koker made a motion to accept resolution number twelve. Resolution number twelve passed.

13. Submitted by Mutual: Non Binding

Whereas carriers are being harassed over projected 2080 issues,

Therefore be it resolved that carriers who have sufficient leave, receive written notification that they are on the projected 2080 list with no further discussion by management until July 31st of that year.

Jan Frymire made a motion to accept resolution number thirteen. Tony Lott moved to amend resolution number thirteen to read: Therefore be it resolved that carriers who receive notification that they are on the projected 2080 list have no further discussion by management until July 31st of that year. Amendment Passed. Resolution number thirteen as amended passed.

14. Submitted by Mutual: Non Binding

Whereas retaining relief carriers is essential to the USPS,

Therefore be it resolved that management cannot require probationary employees to be utilized on any other than their primary route during the first 90 days of employment.

Carrie Smith made a motion to accept resolution number fourteen. Cheri Freeman moved to amend to read: Therefore be it resolved that management cannot require probationary employees to be utilized on more then three routes during the first 90 days of employment. Amendment passed. Monte Hartshorn moved to amend to insert "calendar" after 90 days. Amendment passed. Resolution number fourteen as twice amended passed.

15. Submitted by Mutual: Non Binding

Whereas rural carriers are required to take sick leave by the day,

Therefore be it resolved that rural carriers be allowed to take sick leave in 2 hour increments.

Cindy Koker made a motion to accept resolution number fifteen. Resolution number fifteen failed.

16. Submitted by Mutual: Non Binding

Whereas the USPS pays approximately ½ the pay for NDCBU's than individual curbside boxes and we have more than one type of NDCBU. The older ones take much longer than we are paid for.

Therefore be it resolved the older NDCBU's (approximately 5" X 5" or less compartments) be paid at the same rate as curbside boxes.

Jan Frymire made a motion to accept resolution number sixteen. Resolution number sixteen failed.

17. Submitted by Mutual: Non Binding

Whereas carriers in formula offices have one relief day in the middle of the week and never have 2 days off together unless it involves a holiday or leave,

Therefore be it resolved carriers in formula offices be allowed to choose rotating relief days and that management be required to offer as many Monday relief days as Saturday relief days.

Resolution number seventeen passed with the drop of the gavel.

18. Submitted by Mutual: Non Binding

Whereas new members are not receiving information on the benefits and contractual rights when becoming union members,

Therefore be it resolved that the NRLCA send out to each new RCA union member a contract and include the new health benefit package available to them.

Carrie Smith made a motion to accept resolution number eighteen. Tony Lott moved to postpone indefinitely. Resolution number eighteen was postponed indefinitely.

19. Submitted by Mutual: Non Binding

Whereas carrier pick-up pays a flat rate, no matter the number of trips to the location of the packages or the number of packages picked up,

Therefore be it resolved that carrier pickup pay should reflect the actual number of packages picked up and the number of trips to the location of the packages.

Resolution number nineteen passed with the drop of the gavel.

20. Submitted by Mutual: Non Binding

Whereas in Formula offices J route carriers are required to take Saturday relief days,

Therefore be in resolved in Formula offices, carriers assigned to a J route have the option to take a Saturday or a Monday relief day.

Resolution number twenty passed with the drop of the gavel.

21. Submitted by Mutual: Non Binding

Whereas in Formula offices J route carriers are required to take Saturday relief days,

Therefore be in resolved in Formula offices all carriers will choose their relief day according to office seniority.

Cindy Koker made a motion to accept resolution number twenty-one. Resolution number twenty-one failed.

22. Submitted by South East Washington: Non Binding

Whereas mail count is designed to accurately measure the current work load of a rural route to determine its evaluation, and; whereas, postage rate increases cause severe disruption to normal mail volumes,

Therefore be it resolved that for any contractually scheduled national mail count, no route will be counted until at least 150 days have passed since the rate increase went into effect, unless the route carrier, and route carrier only, opts in the route to be counted during scheduled count period.

Jan Frymire made a motion to accept resolution number twenty-two. Resolution number twenty-two failed.

23. Submitted by South East Washington: Binding: To the National Board

Whereas the Juniors Program, Nursery, and Latch Key Programs at National Convention brings in large number of minor children, and whereas it takes a large number of people to run or oversee the many activities of these programs, and whereas people have been brought in off the street to oversee the Juniors, Nursery, and Latch Key Programs in the past, and whereas the State funding total was created and set before the need to have background checks and before the latch key program was started, and whereas we live in an increasingly dangerous and vicious society,

Therefore be it resolved that beginning with the 2008 National Convention the National Board will fund and provide background checks on all people hired or brought in to help run the Junior Program, Nursery, and Latch Key Program.

Carrie Smith made a motion to accept resolution number twenty-three. Resolution number twenty-three passed.

WARLCA CONSTITUTION AND BYLAWS

JULY 1, 2007 THROUGH JUNE 30, 2008

CONSTITUTION

ARTICLE I (NAME)

SECTION 1: This association shall be known as the Washington Rural Letter Carriers' Association (herein referred to as 'the WARLCA'). The Washington Rural Letter Carriers' Association (WARLCA), by its Secretary-Treasurer, maintains custody and control of the State Association name as well as any State Association logo or symbol. Unauthorized use of the State Association name, logo, or symbol shall be addressed by the filing of an internal union charge or legal action or both.

ARTICLE II (OBJECT)

SECTION 1: The object of the WARLCA shall be: to improve the methods used by rural letter carriers, to benefit their conditions of labor with the United States Postal Service (USPS), and to promote fraternal spirit among its members. This Organization shall not affiliate or merge with any other organization or group without a majority vote of the delegates at a national or special convention or a majority mail referendum vote of all members voting.

ARTICLE III (MEMBERSHIP)

SECTION 1: Membership of the WARLCA shall be in compliance with the NRLCA Constitution and By Laws, Article III, Membership, and composed of:

A. Bargaining Unit Rural Carriers:

Regular Carrier (Designation Code 71)

This would include Regular Carriers who are in injured-on-duty/leave without pay (IOD/LWOP) status and assigned to (980-989) rural routes.

Part-Time Flexible Rural Carriers (Designation Code 76)

Substitute Rural Carriers (Designation Code 72 and 73)

Rural Carrier Associates (RCA) (Designation Codes 74, 78, 79)

Rural Carrier Reliefs: (RCR) (Designation Code 75)

Auxiliary Rural Carriers (Designation Code 77)

Rural Letter Carriers who are serving in the Armed Forces of our country, provided they were members of the WARLCA at the time of their entry into the Armed Forces.

B. Retired Rural Carriers: Rural Carriers who were members in good standing at the time of their retirement, retired on an annuity, and have joined the WARLCA as a retired member.

C. Associates: Former rural letter carriers who were members in good standing and are now working in other postal related jobs, excluding those in management positions, and former rural letter carriers who were members in good standing when they left the service and are not receiving an annuity.

D. Retired Associates: Associates who have been retired on an annuity.

SECTION 2: "Members in good standing" shall be defined as any person who has fulfilled the requirements for membership and who has not voluntarily withdrawn nor been expelled or suspended by the WARLCA

and/or NRLCA. "Good standing" requires the timely payment of dues as defined in the NRLCA Constitution and Bylaws, Bylaws, Article X.1.E.

<u>SECTION 3</u>: Members in categories A-D, as defined in Article III of this Constitution, are entitled to voting rights as follows:

A - Entitled to all voting rights

B - Entitled to all voting rights with the exception of ratification of National Agreements

C and D - Have no voting rights

SECTION 4: Membership shall be in the County Unit and District representing the office from which the route emanates. A Retired Carrier shall have the option of being a member of the County Unit and District in which he/she resides or in the County Unit and District where previously employed as a regular rural carrier.

ARTICLE IV (REPRESENTATION)

SECTION 1: Each County Unit shall be entitled to representation in this Association by one Delegate-at-Large. Each County Unit is also entitled to one delegate for each (5) members or major fraction thereof of its own members, based on the current membership year. Each credentialed and seated delegate is entitled to one vote.

The county credentialed State Paid Delegate to State Convention is responsible for the following:

- A. Specific assignments to a committee as notified by the State President.
- B. Be in attendance at all business sessions of the State Convention beginning with the opening session and not leaving until the Convention has been adjourned.

The county credentialed State Paid Delegate-at-Large is responsible for the following:

- A. Specific assignment to a committee as notified by the State President.
- B. Be in attendance at all business sessions of the State Convention beginning with the opening session and not leaving until the Convention has been adjourned.
- C. Receiving the ballots and Voting Cards for his/her delegation and for returning them at the conclusion of each business session.
- D. Verifying his/her county delegates' attendance at the beginning of each business session.
- E. Reporting any discrepancies in his/her county delegates' attendance to the State President and Mileage and Per Diem Committee as soon as possible.
- F. Submitting an oral report of the State Convention at his/her county meeting during the upcoming year.

SECTION 2: No delegate can be seated from any County Unit without properly signed credentials and current membership dues paid.

<u>SECTION 3:</u> Delegate positions vacant at the time of the State Convention may not be filled by a vote of the delegates present from the subject County Unit or District or from other County Units or Districts, or delegates at the State Convention.

SECTION 4: Election of State Convention delegates by county units shall be by ballot in all cases where there is more than one candidate for each delegate position. If there is a tie for a delegate position, the county shall hold another ballot to break the tie. The delegates shall be listed in order of votes received, with the Delegate-At-Large being the one who received the most votes.

ARTICLE V (MEETINGS)

SECTION 1: The WARLCA shall meet annually (herein referred to as the State Convention) on a date and place assigned to Districts on a rotation basis in the following order: District One, District Four, District Two, District Three. If for any reason the date or place so assigned shall be undesirable or for reasons deemed

advisable by a majority of the State Officers, the Board shall have the authority to change said date or place or set up a date and place by giving official notice to the County secretaries not less than sixty (60) days before the new date.

SECTION 1A: If due to war or other conditions that would make it impossible or impractical to hold a State Convention, the Board shall have the authority to discontinue the State Convention entirely by giving the official notice as provided in Section 1 of this Article.

<u>SECTION 2:</u> Special sessions may be called by the President upon written request of one-half of the County Units in good standing.

SECTION 3: At each State Convention, a report in writing must be rendered by each State Officer and the report then placed on file by the State Secretary.

SECTION 4: Informational and/or training meetings may be authorized by the Board.

ARTICLE VI (QUORUM)

<u>SECTION 1:</u> Seventeen (17) members representing not less than six (6) County Units shall constitute a quorum for the transaction of the business of the WARLCA, but a lesser number than that may adjourn to some future time.

ARTICLE VII (PARLIAMENTARY AUTHORITY)

SECTION 1: The rules contained in the current edition of ROBERT'S RULES OF ORDER NEWLY REVISED shall govern the Association in all cases to which they are applicable and in which they are not inconsistent with the State and National Constitution and Bylaws and any special rules of order the WARLCA may adopt.

<u>SECTION 2:</u> A ballot vote can be called for by a simple majority vote of the delegates present at the State Convention.

ARTICLE VIII (OFFICERS)

<u>SECTION 1</u>: The officers of the WARLCA shall consist of President, Vice President, Secretary-Treasurer, Editor of the WASHINGTON RURAL CARRIER, four (4) District Representatives, and the Retired Carriers' Representative who shall be elected at the State Convention and serve one (1) year, except the District, Retired Representative, Secretary-Treasurer, and Editor, who shall serve two (2) years, or until their successors are elected and installed.

<u>SECTION 1A:</u> Each district shall nominate its own District Representative at a District meeting prior to the State Convention. Notice of said meeting will be sent to all members at least fifteen (15) days prior to the meeting. Such nominations shall then be presented to the Nominating Committee, who shall place them before the State Convention. In case no nomination is made by the District, the Nominating Committee at the State Convention shall select and place in nomination the name of a member of said District. Any delegate who is a member of said District is entitled to nominate from the floor any additional nominees who are qualified.

SECTION 1B: The Retired Carriers' Representative shall be a retired carrier, nominated by a retired carrier and elected by the delegates at the State Convention assembled who shall have been

elected and installed.

SECTION 2: There shall be a Board of Control (herein referred to as the Board) consisting of President, Vice President, Secretary-Treasurer, Editor, four (4) District Representatives, and the Retired Carriers' Representative. This Board shall meet upon the call of the President or by a majority vote of the Board to the Secretary when matters of importance arise that need immediate attention during the interim between meetings of the WARLCA. Each elected officer shall be entitled to a vote on every question before the State Convention.

<u>SECTION 2A:</u> There shall be an Executive Committee consisting of the four (4) District Representatives and the Retired Carriers' Representative.

<u>SECTION 3</u>: Any officer of the WARLCA who shall be separated from the rural service through no fault of his/her own, as determined by the Board, shall hold office until the next State Convention of the WARLCA. However, a former rural carrier who has been appointed to the position of Postmaster, Officer-in-Charge, or other supervisory position, may not vote, hold office, or be appointed to any committee.

SECTION 4: The nomination of officers shall be made by a Nominating Committee of three (3): one (1) of whom shall be selected by the President, one (1) by the Vice President, and these two (2) so chosen shall select the third member. This Committee shall report their list of nominations when called upon. However, before closing the ballot on the nominations submitted by the Committee, the President shall state, "Are there any other nominations?" If so, then the names of the additional nominees shall be added to the list. The election of officers shall take place at each State Convention of the WARLCA. The installation of officers shall take place immediately before adjournment.

SECTION 5: The election of officers shall be by ballot and, in no case, by acclamation, except by unanimous consent, and where there is more than one candidate for the same office, it shall require the majority of all votes cast to elect; and where there are more than two (2) candidates for the same office after the third ballot, the one receiving the least number of votes in each succeeding ballot shall be dropped until the election is had. Write-in votes shall not be considered valid.

SECTION 6: No State Officer may be declared a National delegate by virtue of his/her office.

<u>SECTION 7:</u> To be elected an officer of the WARLCA, one must be a dues paying member of the craft and is ineligible for election if dues are in arrears.

ARTICLE IX (NATIONAL DELEGATES)

SECTION 1: Nominations for National Delegates will be accomplished by submitting nominations on a Nominating Ballot which will be published in THE NATIONAL RURAL LETTER CARRIER in the first issue of February, March, April, and May. Such nominations may include self-nomination. The nominating ballot shall be signed, showing the name and address of the member making the nomination. No member shall be nominated or be a National Delegate who, from the time of nomination through the end of the National Convention, holds a position in management (either permanent or temporary) in the Postal Service, in any other postal craft, or any other job which competes with the Postal Service and/or the NRLCA. A retired Associate member, a non-member, or a craft member who has been separated involuntarily from the Postal Service cannot be nominated, elected, or seated as a National Delegate. Delegates must be an active or retired carrier, in paid status, at the time of nomination, election, and seating as a National Delegate.

SECTION 2: Nominations for candidates for National Delegates shall be received by U.S. Mail in the office of the State Secretary at least forty (40) days prior to the opening of the State Convention. Upon receipt of nomination, the State Secretary shall send by U.S. Mail a notice to the nominee acknowledging receipt of the

nomination.

SECTION 3: The State Secretary shall arrange for the rental of two (2) post office boxes: one post office box for receipt of the ballots, and the other for return of undeliverable ballots. It shall be the duty of the State Secretary to have prepared a ballot listing the nominees for the position of Delegate to the National Convention. The State Secretary shall verify membership on the 40th day prior to the opening of the State Convention, and the ballot shall be mailed to all listed members at least twenty (20) days prior to the opening of the State Convention. The listing of the nominees on the ballot for the position of Delegate to the National Convention shall be in order of random drawing. Random drawing will be done at the State Secretary's office on the 39th day prior to the opening of the State Convention, with two other WARLCA members present that are not nominated and listed on the ballot. Any member may observe the random drawing.

SECTION 4: An envelope marked "Ballot" in which to send the ballot shall be provided each member.

SECTION 5: The sealed envelope containing the ballot shall be mailed in another envelope by the member to the designated post office box. The other envelope also marked "Ballot" shall clearly identify name and address of the member to permit verification of membership enrollment and to maintain the integrity of the voting procedure.

SECTION 6: A Tellers' Committee shall be appointed by the State President. No member whose name appears on the ballot may serve on the Tellers' Committee. Any candidate may observe the ballot tabulation. Ballots shall be returned to a post office box accessible only to the Tellers' Committee. At the end of the cut-off period, said ballots shall be collected and counted at the State Convention.

SECTION 7: The number of candidates to be voted upon by each member shall not be more than the total number of delegate votes to which the WARLCA was entitled the previous year. Appropriate instructions shall be on each ballot stating the number of delegates to be elected and the mailing address of the designated post office box at which it must be received prior to the cut-off date. In reporting the results of the vote tabulation, the candidates shall be placed on a roster in accordance with the number of votes received. In case of a tie, the Tellers' Committee will decide who is to be listed first with a coin toss.

SECTION 8: From the elected National Delegates, the Delegate-At-Large will be filled by State officer ranking, beginning with the State President, provided that he/she is a regular elected delegate. In addition, other National-Paid Delegates and State-Paid Delegates shall be named in accordance with the plurality of votes received. The required number of delegates for the WARLCA, in accordance with the National Constitution, shall be declared regular delegates, and the remaining candidates shall be declared alternates in the order of their finish. If a delegate decides not to attend National Convention and either notifies the State Secretary in writing or does not check in with the National Convention Credentials Committee by noon on the first day of the National Convention, all the following delegates will move up in order of votes received.

SECTION 9: The WARLCA will pay all regular credentialed delegates to National Convention that are not reimbursed by National, the same way and rate that National reimburses, up to a total dollar cap decided by the WARLCA board at the first board meeting of the year. If the reimbursement amount exceeds the set total dollar cap, each delegates' reimbursement will be reduced by an equal percentage to comply with the cap. Further, all regular credential State-paid delegates to the National Convention must attend all business sessions, Western State caucus, and at least one seminar. If a State-paid delegate does not meet his/her delegate's responsibilities, the remainder of the WARLCA delegates will decide before the end of the National Convention and before receiving the reimbursement if that delegate is to receive all or any of the State-paid funds due to not meeting his/her responsibilities.

SECTION 10: Paid delegates to the National Convention are required to give a report of said Convention

at their county meeting before the next year's State Convention. Paid delegates are to attend all association general sessions at the National Convention with the following permitted exceptions upon the approval of the National Delegate-at-Large:

- A. Specific assignments to a committee
- B. Required to man a booth
- C. Illness

The Delegate-at-Large shall be responsible for the following:

- A. Polling delegates for their preferences for the seminar they wish to attend, and then ensuring at least one delegate covers each of the sessions.
- B. Taking roll of the delegates at the beginning of each general session.
- C. Establishing an adequate seating space for the Washington Delegation, including placement and collection of seat back covers and the Washington sign.
- D. Reporting to the Board any problems concerning delegates meeting their responsibilities at the convention.
- E. Collecting the ballots for his/her delegation and returning the ballots to the National Tellers' Committee after his/her National delegates have voted.
- F. Submitting a single report to the State Board for publication in the Washington Rural Carrier.

ARTICLE X (IMPEACHMENT AND REMOVALS)

<u>SECTION 1:</u> In case of neglect of duty or violation of this Constitution on the part of any officer in the WARLCA or subordinate Unit thereof, in the interim of State Conventions, the Board shall have the power to suspend such officer after a fair hearing and subject to an appeal to the next State Convention.

ARTICLE XI (APPEALS)

SECTION 1: Any member aggrieved by any action of a State Association, or Officer thereof, shall have the right to appeal to the State Board. Such appeal must be in writing and must be filed with the State President within thirty (30) days of the action. Within ten (10) days of receipt of such appeal, the State President shall cause to be notified all members of the State Board and NRLCA Assigned Executive Committee Representative, and also request that the charging party provide a letter outlining the specific charges, complete documentation, and relief sought. The letter outlining the specific charges, complete documentation, and relief sought must be returned within twenty (20) days of receipt of such request. Upon receipt, the State President shall cause a copy to be forwarded to the charged party for response. The charged party will have twenty (20) days to respond in writing and provide documentation to the State President. The State Board will review the charging party's letter of specificity, documentation, relief sought, and the response of the charged party. The State Board is authorized, in consultation with the NRLCA assigned Executive Committee Representative, to take the necessary action to resolve the issue within thirty (30) days, unless extensions of time limits are necessary, not to exceed an additional fifteen (15) days. If the State Board resolves or is unable to effect the relief sought, all parties must be notified in writing.

SECTION 2: Any member not satisfied with this decision, or any action of the State Board on said appeal, shall have the right to appeal to the National Board. This appeal must be in writing and must be filed with the President of the National Association within thirty (30) days of receipt of the State Board's decision.

SECTION 3: At any level of appeal, all members shall be afforded the rights of due process, and all members have the right to appeal an adverse decision to the next level. At any time, the National Board shall have full authority to intervene to protect the members of this Association. All correspondence shall be by certified mail, return receipt requested. All costs of the State Investigation and action shall be borne by the State Association, and all costs of the National Appeals Committees shall be borne by the National Association. No court proceeding may be instituted until and unless the appeal procedures provided herein have been exhausted.

ARTICLE XII (AMENDMENTS)

SECTION 1: The Constitution and Bylaws shall take effect immediately upon adoption.

SECTION 2: This State Constitution and Bylaws shall be in harmony with the National Constitution and Bylaws. The county Unit is subordinate to the WARLCA, and the WARLCA is subordinate to the NRLCA. Any provisions of this Constitution and Bylaws which conflicts with any Federal or State Law, regulation, or ordinance shall be inoperative as to those jurisdictions in which said Federal or State Law, regulation, or ordinance is in force.

SECTION 3: Constitution and Bylaws amendments shall become effective upon adjournment of the State Convention unless otherwise stipulated and can only be amended by submitting the amendment in writing at a State Convention and shall require a two-thirds vote to amend.

BYLAWS

ARTICLE I (DUTIES OF OFFICERS--PRESIDENT)

SECTION 1: The President shall preside at all meetings of the WARLCA and of the Board and enforce all laws thereof. He/She shall sign all papers and documents that require his/her signature to properly authenticate them.

SECTION 2: Previous to the first day of each State Convention, he/she shall appoint from the list of regularly elected delegates, then in the hands of the Secretary, a committee of three (3) on Credentials, a committee of at least four (4) on Tellers, a committee of three (3) on Constitution and Bylaws, a committee of three (3) on Resolutions, and a committee of three (3) on Finances. On the first day of the State Convention, he/she shall also appoint from said delegates an Auditing Committee of three (3) members; a committee of three (3) on Mileage and Per Diem; a committee of three (3) on THE WASHINGTON RURAL CARRIER, a committee of three (3) on Media, a committee of three (3) on Minutes, a committee of three (3) on Hospitality, and a committee of four (4) on Sergeant at Arms. He/She shall be responsible that a Nominating Committee be appointed according to Article VIII of the Constitution of the WARLCA. He/She may appoint any other Convention Committee advisable and may also appoint more delegates to serve on a committee if so needed.

SECTION 2A: The President can, if necessary, ask the Constitution and Bylaws Committee, the Resolutions Committee, the Tellers' Committee, and/or the Finance Committee to meet up to two (2) days prior to the State Convention. These persons would be credentialed delegates to the Convention. The President can, if necessary, authorize a stipend of \$75 per day to any/all delegates serving on these committees that were asked to meet prior to State Convention.

SECTION 2B: On the first day of the State Convention, the President will ask the elected convention delegates to decide by voting if they want to hear resolutions and proposed Constitution and Bylaws changes from the floor during new business. The Resolutions Committee and Constitution and Bylaws Committee will only be responsible for Resolutions and proposed Constitution and Bylaws changes that have been submitted and passed by county units, and those submitted by the Finance Committee that fall within the parameters of their responsibility. If the delegation decides to hear Resolutions and proposed Constitution and Bylaws changes from the floor during new business, then the delegate who is submitting it must use the proper form, have enough copies for all elected delegates, and submit them to the Vice President by the close of business the second day of the

convention.

SECTION 3: His/Her decisions upon all questions of law shall be final during the recess of the WARLCA. He/She shall report all such decisions to the WARLCA at its State Convention for approval or rejection. Such decisions, when approved or revised by the WARLCA, shall have all the effect and force of the general laws of the WARLCA.

SECTION 4: At the close of each State Convention, he/she shall, in conjunction with the Board, appoint the Auto Insurance Director, Provident Guild Director, Political Action Committee Director, and have the authority to fill any vacancies therein during the recess. Also, in conjunction with the Board, he/she shall evaluate the work of the State Steward, and if in the best interest of the WARLCA, terminate the incumbent State Steward and nominate a replacement.

<u>SECTION 5:</u> He/She shall fill all vacancies pro tem caused in any way in the Board of the WARLCA subject to the approval of the remaining members of the Board.

<u>SECTION 6:</u> He/She shall have power to grant charters and, in conjunction with the Secretary, issue them during the interim between State Conventions of the WARLCA. He/She shall perform other duties as the Constitution and Bylaws require.

<u>SECTION 7:</u> The President, with approval of the State Board, may place in trusteeship any Local/County/ District Association (Unit) or subordinate body for any of the following reasons:

- A. To uphold the principles and integrity of this Constitution;
- B. To correct corruption or financial malpractice;
- C. To assure performance of collective bargaining agreements or other duties of a bargaining representative;
- D. To restore democratic procedures; and
- E. To otherwise carry out the legitimate objectives of the State Association.

SECTION 7A: The trustee shall assume immediate control and authority of the Local/County/District Association, with full authority over the Officers and property thereof. The trustee shall continue to act in such a capacity for the duration of the trusteeship.

<u>SECTION 7B:</u> Within 30 days of the imposition of the trusteeship, a hearing shall be held before an impartial member of the State Association acting as a hearing officer, to determine facts on continuing the trusteeship. All interested persons shall have the right to present evidence at the hearing to the hearing officer, who shall have the sole discretion on the conduct and procedures at the hearing.

<u>SECTION 7C:</u> The hearing officer shall report, as soon as practicable, after the close of the hearing, the findings and recommendations to the President. The President may accept or reject these findings and recommendations, and the trusteeship may be continued or terminated accordingly.

<u>SECTION 7D:</u> Upon a petition filed with the President, no earlier than six months after the appointment of the trusteeship, and at six-month intervals thereafter, any party may request termination of the trusteeship. The President, acting on such petition, or at any time, may terminate the trusteeship and restore government to the Local/County/District Officers.

SECTION 7E: Any party not satisfied with the decision of the President under Sections 7C or 7D shall have appeal rights as provided under Constitution Article XI (APPEALS).

SECTION 1: The Vice President shall preside in the absence of the President, and in the case of death, resignation, disqualification, refusal, or neglect of the President to discharge the duties of his/her office, the Vice President shall become the President and serve until such time as his/her successor shall be duly elected and installed.

ARTICLE III (SECRETARY-TREASURER)

SECTION 1: The Secretary-Treasurer shall keep a correct record of the proceedings of the WARLCA, and read or cause to be read, all communications, reports, etc. He/She shall affix the seal of the WARLCA to all official documents. He/She shall prepare for publication in the *Washington Rural Carrier*, an overview of the speakers at the WARLCA State Convention or special meetings and a correct record of the business session of the WARLCA State Convention or special meetings, not later than one (1) month after the close of each State Convention or special meeting, and shall also present on the first day of the State Convention a complete statement of the condition of the WARLCA, including a statement of the membership of same.

SECTION 2: He/She shall conduct the correspondence of the WARLCA, keep a record, and submit same when demanded by the Board.

<u>SECTION 3:</u> He/She shall have charge of the seal, books, papers, and documents belonging to the WARLCA; shall deliver to the WARLCA, or his/her successor, all property of the WARLCA at the expiration of his/her term of office, or upon an earlier termination thereof; he/she shall be given an itemized receipt for all property delivered by the party or parties receiving same.

SECTION 4: He/She shall keep a true and correct account between the WARLCA and the County Units.

SECTION 5: He/She shall perform all the duties of the Treasurer as are required by this office.

SECTION 6: He/She shall receive all monies due the WARLCA and shall deposit all monies in a convenient depository; such deposits to be made in the name of the "Washington Rural Letter Carriers' Association" and any interest thereon shall be credited to the funds of the WARLCA.

SECTION 7: The Secretary-Treasurer will issue checks in payment of all properly itemized invoices, statements, vouchers, authorized payroll payments, and for other obligations of the WARLCA as directed by the State Board. He/She will have the President, Vice President, State Steward, and one District Representative review the payments and supporting documents on a quarterly basis. Each District Representative shall be responsible for reviewing one quarter of each year.

<u>SECTION 8:</u> The Secretary-Treasurer may at each State Convention employ a stenographer to take down the proceedings as directed by the State Board, and the cost shall be paid out of the treasury of the WARLCA.

<u>SECTION 9:</u> He/She shall render a report to the WARLCA at its State Convention or to the President and Board when they may request it, showing in detail the receipts and expenditures of the WARLCA's funds as shown by his/her books.

<u>SECTION 10:</u> After the close of each State Convention, the Secretary shall send the appropriate resolutions to the National Secretary-Treasurer, keeping a copy on file.

SECTION 11: Upon receipt of the nominations for the position of Delegate to the National Convention, he/she will have prepared a ballot listing the nominees for the position of Delegate to the National Convention, and the ballot shall be mailed to all members at least twenty (20) days prior to the opening of the State Convention. He/She will fulfill all duties concerning delegates to National Convention in accordance with

Article IX (National Delegates) of the Constitution of the WARLCA.

SECTION 12: He/She will notify all members, at least fifteen (15) days prior to the opening of the State Convention, of the time and place, the nominating and election procedures, and the offices to be filled. This notice may be included with the National Delegate ballot mailed to each member.

<u>SECTION 13:</u> He/She will retain for one (1) year in a safe location all ballots used at the State Convention. These ballots should be placed in envelopes marked to indicate for which election they were used.

ARTICLE IV (EXECUTIVE COMMITTEE)

<u>SECTION 1:</u> The Executive Committee, or a majority of them, shall act as Trustees of the WARLCA, and in conjunction with the President, have general supervision and control of the WARLCA.

<u>SECTION 2:</u> At the expiration of their term of office, or upon an earlier termination thereof, they shall turn over to the WARLCA or their successors, all books, papers, and other property they may have in their possession belonging to the WARLCA.

<u>SECTION 3:</u> It shall be the duty of the Executive Committee members to aid in keeping carriers in their particular Districts interested in WARLCA work and in keeping up the membership of their Districts. They shall perform such other duties as the WARLCA may, from time to time, direct.

<u>SECTION 4:</u> It shall be the duty of the Executive Committee members to search out future Convention sites in their District and to work with the board on establishing a Convention site contract for said Convention. They are also to enlist Convention committee members to help assist them in holding the Convention in the appropriate Convention year for their District.

ARTICLE V (EDITOR)

SECTION 1: The Editor shall publish three (3) issues of the WASHINGTON RURAL CARRIER. The State Board shall have the authority to authorize special editions. Also, the State Board shall have the authority to identify which articles and notices will be published in each issue, and to determine and change issue dates as current events may require.

SECTION 2: The Editor will receive a salary after the mailing of each issue of the WASHINGTON RURAL CARRIER. Said salary will be determined at each State Convention. The Editor will also receive a salary for the publication of the State Convention program, if directed by the Board to publish it. Said salary will be determined at the State Convention.

<u>SECTION 3:</u> The Editor shall mail each issue of the WASHINGTON RURAL CARRIER to all members of the WARLCA and will be reimbursed for all expenses incurred in publication and mailing.

ARTICLE VI (STATE OFFICERS' EXPENSE)

<u>SECTION 1:</u> The elected WARLCA State Officers that shall receive a salary are the Secretary-Treasurer and Editor. The appointed WARLCA State Officers that shall receive a salary are the State Steward, Senior Assistant State Steward, Assistant State Stewards, and Area Stewards. The elected and appointed WARLCA State Officers' salaries shall be decided at each State Convention.

<u>SECTION 2:</u> All elected and appointed state officers of the WARLCA shall be reimbursed for all office expenses for representing the WARLCA. Actual expenses, as defined in Board policy, will be reimbursed. Reimbursement of said expenses shall be made by the Secretary-Treasurer upon receipt of a voucher and

supporting documents. Association Day of Pay (ADOP) will be reimbursed at a 44K, step 12, or their route evaluation, whichever is higher, for all elected and appointed State Officers, excluding the Retired Carriers' Representative, for all days used for authorized business of the WARLCA. Association Day of Pay (ADOP) will not be compensated to attend the State Convention or National Convention while they are in session, but may be authorized by the Board for other required business or trainings. All lost sick and annual leave days will be compensated at a 44K, step 12, or their route evaluation, whichever is higher, at the time of loss. All elected and appointed WARLCA State Officers will be reimbursed mileage at the IRS allowable rate for authorized business of the WARLCA. All elected and appointed State Officers will be reimbursed actual hotel expenses if an overnight stay is required. All elected and appointed State Officers will be reimbursed \$30 food per diem while on travel status, and an overnight stay is required. All elected and appointed State Officers will not be paid actual expenses for business sessions of State or National Convention, but will be reimbursed the same as regular delegates to State and National Convention if they qualify as a credentialed regular delegate. All office expenses, ADOP, mileage, hotel, and food per diem reimbursements must meet Board polices, be approved in advance if possible, and be submitted on a voucher with supporting documents.

SECTION 3: The State President, in conjunction with the Board, shall recommend to the NRLCA the member that the WARLCA would like to have appointed as State Steward. His/her service shall be continuous until terminated by the State President in conjunction with the Board or National President or by resignation. The State Steward shall work with and be responsible to the State President and the Board. The State Steward shall supervise and administer the Steward Program within the State using the following guidelines:

A. The State Steward or designee shall make Step 3 Grievance appeals. The State Steward will coordinate all efforts closely with the Regional Representative and the Grievance Specialist and report monthly to the appropriate Local Steward and the grievant.

B. Be responsible for certifying and maintaining certification records of all Local and Area Stewards.

C. In the event there is a need to fill or replace an Area or Local Steward position, the State Steward has the responsibility to the WARLCA and NRLCA in naming an individual to temporarily serve as Steward.

D. Be responsible for the distribution of Steward Manuals and Grievance forms to and Local Steward, as well as for Steward training.

E. The State Steward will approve payment of expenses incurred by the Area and Local Stewards, while they are involved in grievance-related business. Reimbursement shall be made by the State Secretary-Treasurer, after he/she reviews the voucher, supporting documents, and receives the State Steward's approval. Expenses for the Area and Local Stewards shall be submitted no later than three (3) months after the expense has been incurred. The State Steward will review payment of expenses incurred by the Assistant State Stewards while they are involved in grievance-related business. Reimbursements shall be made by the State Secretary-Treasurer, after he/she reviews the voucher and supporting documents. Expenses for the Assistant State Stewards shall be submitted no later than one (1) month after the expense has been incurred. All reimbursements for Assistant, Area, and Local Stewards must first meet the guidelines of the State Board Policy and State Constitution and Bylaws. Any expense that does not meet the guidelines must be reviewed by the State Board before payment can be made, and only paid after Board approval.

F. The State Steward, in conjunction with the State President, shall appoint from the Assistant State Stewards, an Acting State Steward when he/she is unavailable.

The Acting

State Steward will be in charge of all State Steward duties that need to be performed while the State Steward is unavailable.

SECTION 3A: The State President, in conjunction with the Board and the State Steward, shall recommend to the NRLCA, the members that the WARLCA would like to have appointed as Senior Assistant State Steward, Assistant State Stewards, and Area Stewards. Their service shall be continuous until terminated by the State President in conjunction with the Board, or National Board,

or by resignation. The Senior Assistant State Steward, Assistant State Stewards, and Area Stewards shall work with and be responsible to the State Steward in the performance of their official duties. The geographical area served by each Senior Assistant State Steward, Assistant State Steward, and Area Steward shall be determined by the State Steward in conjunction with the Board

SECTION 3B: Charges against a State, Senior Assistant State, Assistant State, Area, or Local Steward must be in writing and filed with the State President of the WARLCA by a member within thirty (30) days of the time that knowledge of the alleged offense comes to such members. Within ten (10) days of receipt of such appeal, the State President shall cause to be notified all members of the State Board and NRLCA Assigned Executive Committee Representative and also request that the charging party provide a letter outlining the specific charges, complete documentation, and relief sought. The letter outlining the specific charges, complete documentation, and relief sought must be returned within twenty (20) days of receipt of such request. Upon receipt, the State President shall cause a copy to be forwarded to the charged party for response. The charged party will have twenty (20) days to respond in writing and provide documentation to the State President. The State Board will review the charging party's letter of specificity, documentation, relief sought, and the response of the charged party. The State Board is authorized, in consultation with the NRLCA Assigned Executive Committee Representative, to take the necessary action to resolve the issue within thirty (30) days, unless extensions of time limits are necessary, not to exceed an additional fifteen (15) days. If the State Board resolves or is unable to effect the relief sought, all parties must be notified in writing.

SECTION 3C: Any member not satisfied with this decision, or any action of the State Board on said appeal, shall have the right to appeal to the National Board. This appeal must be in writing and must be filed with the President of the National Association within thirty (30) days of receipt of the State Board's decision.

SECTION 3D: At any level of appeal, all members shall be afforded the rights of due process, and all members have the right to appeal an adverse decision to the next level. At any time, the National Board shall have full authority to intervene to protect the members of this Association. All correspondence shall be by certified mail, return receipt requested. All costs of the State Investigation and action shall be borne by the State Association, and all costs of the National Appeals Commission and Appeals Committees shall be borne by the National Association. No court proceeding may be instituted until and unless the appeal procedures provided herein have been exhausted.

<u>SECTION 4:</u> Each State Officer and Appointed Officer will submit a proposed budget for the operating expenses of their office for the coming fiscal year to the Board for approval.

SECTION 5: The WARLCA will operate on a budget each year.

ARTICLE VII (REVENUES AND DUES)

SECTION 1: The revenues of the WARLCA shall be derived from per capita dues and allowance for insurance promotions.

SECTION 2: The Board may levy a special tax when conditions seem to demand it, but the whole amount of such levies in any one year shall not exceed the amount of State per capita for that year.

SECTION 3: The State shall underwrite the County units, the Convention Fund, and any special funds as needed. The State per capita dues for regular carriers, part time flexible carriers, and associate members shall be 1% of the yearly salary of a 40-hour route at Step A on the salary schedule as of January 15 of each year. The State per capita dues for relief carriers shall be 35% of the regular carriers' State per capita dues as

calculated above. The State per capita dues for retirees shall be a set rate of \$27.00. The annual dues will be the total of the State per capita dues in addition to the National per capita dues. All per capita dues described in this article shall be rounded up to the nearest whole dollar and become effective July 1 of each year. The portion of the State per capita dues to be distributed to the County Units, Convention Fund, and other special funds shall be decided at each State Convention. The membership and fiscal year shall begin July 1 and end June 30.

SECTION 4 The Auxiliary of the WARLCA shall be funded through an annual assessment of \$4.00 in addition to the National Auxiliary per capita dues for all members, excluding associate members, as long as the auxiliary is responsible for, funds, and administers the Junior Program at State Convention, the Scholarship Program, and provides a financial statement at the beginning of State Convention to the WRLCA. If the Auxiliary is unable to be responsible for, administer, and fund the Junior Program and Scholarship Program, then a \$3.00 assessment per member, replacing the State and National Auxiliary assessment per member, excluding associate members, will be set aside to fund the Junior Program and Scholarship Program. Said assessment shall be in addition to the current per capita dues of the members of the Association. In the event the auxiliary ceases to be active, the State Board shall oversee the Junior Program and Scholarship Program.

SECTION 4A: The Scholarship Program will consist of (2) two \$1,000.00 scholarships to be given annually. The current eligibility requirements will remain the same. Scholarships will be awarded at the State Convention.

SECTION 4B: The Junior Program shall be funded with the remainder of the assessment funds. The Junior Program will consist of three days of activities, a junior banquet, an "Americanism" Program, and at least one paid chaperone age 21 or over. If there are any remaining funds, the State Board may approve helping a Junior Officer to National Convention. Such help may not exceed \$400.00. The State Board may also hold any unspent funds in a savings account. Such savings account may not exceed \$300.00. If there are still any remaining funds, they shall be returned to the Associations general fund.

SECTION 5: The 2010 National Convention shall be funded through an annual assessment of \$26.00 for all members, excluding retired members. The annual assessment will start July 1, 2006 and will cease June 30, 2010. The annual assessment will be deposited into the 2010 National Convention Account at Atlanta Postal Credit Union (APCU) each quarter. This annual assessment shall be in addition to the current per capita dues of the members of the Association.

ARTICLE VIII (CHARTERS)

SECTION 1: Charters shall be granted County Units upon members' application and payment of one (1) year's dues for each member. The amount of dues shall be specified in ARTICLE VII of the By-Laws.

ARTICLE IX (FISCAL YEAR)

SECTION 1: The fiscal year of the WARLCA shall be from July first (1) to June thirtieth (30th). The term of the officers of the WARLCA shall be from the time of installation to the installation of their successors.

SECTION 2: The fiscal year of the County Units and District Associations shall be from July first (1) to June thirtieth (30th).

> ARTICLE X (RULES GOVERNING COUNTY UNITS AND DISTRICT ASSOCIATIONS)

SECTION 1: Districts and Counties:

DISTRICT ONE (1) shall be composed of the County Units of: ISLAND-SKAGIT-SAN JUAN (Island, Skagit and San Juan Counties); K-S (King and Snohomish Counties); WHATCOM (Whatcom County).

DISTRICT TWO (2) shall be composed of the County Units of: PENINSULA (Clallam, Jefferson, and Kitsap Counties); LOWER COLUMBIA (Clark, Skamania, Cowlitz, Wahkiakum, and the 986 offices of Pacific and Klickitat Counties); MUTUAL (Pierce, Grays Harbor, Thurston, Mason, Lewis, and the non 986 offices of Pacific Counties)

DISTRICT THREE (3) shall be composed of the County Units of: NORTH CENTRAL WASHINGTON (Chelan, Douglas, Grant, and Okanogan Counties); NORTH EAST WASHINGTON (Stevens, Ferry, and Pend Oreille Counties); EAST CENTRAL WASHINGTON (Lincoln and Spokane Counties)

DISTRICT FOUR (4) shall be composed of the County Units of: SOUTHEAST WASHINGTON (Walla Walla, Columbia, and Garfield Counties); WHITMAN-ASOTIN (Whitman and Asotin Counties); APPLE VALLEY (Adams, Franklin, Kittitas, Yakima, Benton, and the non-986 offices of Klickitat Counties).

SECTION 1A: Each District shall hold at least one (1) meeting a year by either combining with another District to have a joint meeting or by having its own District meeting. If the District meetings are combined with another District, the meeting location shall be in the District nominating the District Representative. All members of each District shall be notified of the time and place of said meeting or meetings. Notice will be sent to all members fifteen (15) days prior to an election.

SECTION 2: Secretaries of the County Units shall remit to the State Secretary-Treasurer within fifteen (15) days of their receipt, all monies for per capita dues. County secretaries shall also inform the State Secretary-Treasurer of any changes in membership (such as change of address, resigned, or deceased) in a timely manner.

SECTION 3: Each County Unit at their annual meeting shall elect their delegates to the State Convention by ballot in all cases where there is more than one candidate for each delegate position. Delegates will be listed in accordance with the number of votes received. The delegate receiving the most votes will be the Delegate-at-Large. In case of tie, the members will decide the placement with the toss of a coin, except for the delegate at large position, which will be decided by another ballot. Each County Secretary shall immediately, after the regular annual meeting of their County Unit, fill out in duplicate, credentials of Delegate-at-Large, Regular, and Alternate delegates to the State Convention in order of votes received. The duplicate is to be retained for identification by the delegate, and the original is to be sent to the State Secretary with proper endorsement by the County President and the County Secretary. Also, each County Secretary shall submit the names of the newly elected County Officers to the State Secretary. Such newly elected officers shall assume office upon election.

SECTION 3A: The County Secretary, when submitting resolutions and proposed changes to the Constitution and Bylaws to the State Secretary, shall submit them in the proper form as follows: Make a copy of each resolution and proposed change to the Constitution and Bylaws, preferably typewritten, following the form provided by the State Secretary-Treasurer, and state whether it is a resolution or a proposed change to the Constitution and Bylaws.

SECTION 4: Each County Unit shall hold its annual meeting after October 1st and at least forty (40) days prior to the State Convention and the regular meeting shall be designated by statute. The County Secretary

will notify all County members, their District Representative, State Secretary, State President, and State Steward at least fifteen (15) days prior to the election of County Officers and Delegates. They shall make and adopt such other Bylaws as their needs may suggest, and such laws must harmonize with this code of laws.

SECTION 5: All County Unit or District Constitution and Bylaws shall be in harmony with the National and State Constitution and Bylaws.

SECTION 6: The County Unit or District Association is subordinate to the WARLCA. Likewise, the WARLCA is subordinate to the NRLCA. Any County Unit or District Association or any member thereof who shall cause to have introduced or endeavor to have passed in Congress or the State Legislature any measure relative to legislation for Rural Carriers which has not had the approval of the WARLCA or its officers shall have charges preferred against such County Unit, District, or member, as the case may be, and if charges are proven true, the County Unit, District, or member shall be indefinitely suspended.

ARTICLE XI (COMMITTEES)

SECTION 1: The Committee on Credentials shall examine the credentials of all delegates to the State Convention. They shall also back up and assist the Tellers' Committee, when voting on the issues on the floor at the State Convention requires the use of a 2nd Tellers' Committee.

SECTION 1A: On the first day of the State Convention, the Credentials Committee will give a preliminary report. Final report of the Credentials Committee shall be given not later than ten (10:00) a.m. on the second day of the State Convention. All delegates shall be seated by the passing of the final report of the Credentials Committee.

SECTION 2: The Committee on Audit shall examine the books of the Secretary-Treasurer, as well as the reports of the County Units, and shall report to the WARLCA when called upon.

SECTION 3: The Committee on Mileage and Per Diem shall make up a listing of delegates and/or elected and appointed officers who are entitled to receive mileage and per diem as per the WARLCA Constitution and Bylaws. The listing shall show the name, title (Delegate-at-Large or State-Paid county delegate, elected, or appointed officer), mileage, and per diem due for each person.

SECTION 4: The duties of the Committee on Constitution and Bylaws shall be: To examine all changes proposed for amending or changing the Constitution and Bylaws that have been passed and submitted by the county units, and those submitted by the Finance Committee that fall in parameters of their responsibility. They may examine and correct, when called upon, proposed laws governing County Units or District Associations so that they will not conflict with the National or State Constitutions.

SECTION 5: The duties of the Committee on Resolutions shall be to examine all proposed resolutions passed and submitted by the county units, and those submitted by the Finance Committee that fall in parameters of their responsibility, and present same to the elected delegates, identifying them as binding (and to whom) or non binding. The Resolutions Committee can also propose any courtesy resolutions they deem necessary and present same to the elected delegates at State Convention.

SECTION 6: The duties of the Tellers' Committee shall be: To count the ballots for National Convention delegates and to total the results of paper count voting on the floor. If the Tellers' Committee is off the floor, then the Credentials Committee will act as a backup to the Tellers' Committee concerning paper count voting on the floor.

<u>SECTION 7:</u> The duties of the Finance Committee shall be: To review the finances of the past year and to review any suggestions from the Board and delegates for the next year, and then to propose financial

suggestions concerning State, County, and Auxiliary dues, salaries, and expenses for the upcoming year.

SECTION 8: The duties of THE WASHINGTON RURAL CARRIER Committee shall be: To review the expenses to publish and mail THE WASHINGTON RURAL CARRIER and to make any suggestions concerning future publications.

<u>SECTION 9:</u> The duties of the Nominating Committee shall be: To seek nominees for the offices open and present these names to the Convention delegates.

SECTION 10: The duties of the Media Committee are to present the proposed resolutions and constitution and bylaw changes to the delegates on the LCD as well as any reports and/or presentations.

SECTION 11: The duties of the Minutes Committee are to tape record the State Convention and keep a written record of the business sessions, as well as an overview of the speakers.

SECTION 12: The duties of the Hospitality Committee are to help in the hospitality room and write thank you notes to the speakers and guests.

<u>SECTION 13</u>: The duties of the Sergeant of Arms are to facilitate the recess as well as the use of the stopwatches during proposed resolutions and constitution and bylaw changes.

SECTION 14: The duties of all other committees shall be those usual to such committees, and they shall report when called upon.

ARTICLE XII (STATE CONVENTION MILEAGE AND ALLOWANCE)

SECTION 1: The WARLCA shall pay round trip mileage at 33 cents a mile to each county credentialed regular delegate who attends all 3 days of the State Convention, provided that this shall in no way increase the total number of delegates to which each county unit is entitled, and also in compliance with section 3 of Article XII of the State Constitution and By Laws concerning mileage and allowance. The mileage will be computed using a current door-to-door computer mileage program.

SECTION 2: The WARLCA shall pay a State Convention allowance of \$250 to each county credentialed regular delegate who attends all 3 days of the State Convention, provided that this shall in no way increase the total number of delegates to which each county unit is entitled, and also in compliance with section 3 of Article XII of the State Constitution and Bylaws concerning mileage and allowance.

SECTION 3: The Board will set a total dollar cap at the first budget Board meeting of the year for the following State Convention allowance and mileage expense reimbursement. If the number of county credentialed regular delegates' reimbursement for State Convention allowance and mileage exceeds that set total dollar cap, each delegates' reimbursement will be reduced by an equal percentage to comply with the cap.

ARTICLE XIV (PRINTING CONSTITUTION AND BYLAWS)

SECTION 1: The Secretary shall have the Constitution and Bylaws printed in the Convention issue of THE WASHINGTON RURAL CARRIER, which will be mailed to all members.

ARTICLE XV (AMENDMENTS)

SECTION 1: The Constitution and Bylaws shall take effect as soon as adopted.

SECTION 2: This State Constitution and Bylaws shall be in harmony with the National Constitution and Bylaws. The County Unit is subordinate to the WARLCA, and the WARLCA is subordinate to the NRLCA. Any provisions of this Constitution and Bylaws which conflicts with any Federal or State Law, regulation, or ordinance shall be inoperative as to those jurisdictions in which said Federal or State Law, regulation, or ordinance is in force.

SECTION 3: Constitution and Bylaws amendments shall become effective upon adjournment of the State Convention unless otherwise stipulated and shall require a two-thirds vote to amend.
