

I waited until the last minute to write this article because the Senate was supposed to vote on a continuing resolution on the appropriations bill which contains the 6 day a week delivery language. Senators McCain (R-AZ) and Senator Coburn (R-OK) have introduced an amendment #68 to reduce the requirement to 5 day delivery. The vote should happen soon so this may be over by the time you get this issue of the paper. Alerts on this vote have been going out through the National Grassroots E-Network Activist email list as well as our own updates@WARLCA.com. If you have not signed up for these alerts, please do so. This is not the time to take your job for granted. We must get every carrier involved and active if we are going to survive as a craft. Even though this particular vote maybe already a done deal, I can't stress enough how important it is for all craft members to be up to date in the political arena of the Postal

Your Vote, Your Duties, Your Responsibilities

State Convention: WHAT IS YOUR VOTE WORTH? <u>Priceless</u> - the same as each and every one of your fellow county members. ALL county credentialed delegates get paid the same rate for mileage and the same convention allowance, no matter if you are a relief carrier (RCA), regular carrier, or retired carrier.

Here are your duties as a credentialed county delegate to State Convention:

Ø Specific assignments to a committee as notified by the State President.

Ø Be in attendance at all business sessions of the State Convention beginning with the opening session at **9 AM on Sunday** and not leaving until the Convention has been adjourned on Tuesday.

All members are welcome to attend any and/or all of convention, however to be reimbursed by the State you must attend all 3 days of State Convention and be credentialed by your county. Make sure you attend your county meeting and ask to have your name placed on the ballot for State Convention delegate to the 2013 State Convention in Oak Harbor, WA!

National Convention Delegates: The National Convention delegate nomination form will be in the February issue through the May issue of the National paper. All you need to have your name on the ballot is to complete this nomination form and mail it to the State Secretary. I will acknowledge the receipt of your nomination form by mail. If you have not gotten a return letter from me 7 days after you sent me your nomination form, please call (509) 710 7840 to verify that I received it. Otherwise your name might not be on the ballot.

Training: As I write this article I have just gotten back from National Secretary-Treasurer's training. While it was only a three day training, I have 11 pages of notes taken on the computer. One thing for certain, there will always be changes and I learn new things every year. DOL (Department of Labor) is putting the States and Counties on notice for timely LM submissions, which I can proudly say every county filed timely for 11/12 year. I hope all the 13/14 Fiscal Year County Officers can attend the state convention county officer training (free dinner), and I look forward to seeing you all. I am here to be your resource so call anytime at (509) 710-7840.

Membership: We are at 1770 members, down from 1805 at 2012 State Convention and 1840 in 2011 State Convention. If we drop below 1750 we will lose another delegate position to National Convention. With auxiliary routes being absorbed rather than converted to regular and new DPS standards with LLV's we are not increasing in routes. Also, as many of you are experiencing, the USPS is dragging their feet about hiring and we have 200

less RCAs to recruit. I feel for the RCAs waiting for a route. It took me 10 years to get a route, and already in my office a RCA has been waiting for 11 years. If you have any TRCs in your office please let them know that they will be fired in August 2013, since that position will be eliminated. Now is the time for them to take the test and get on a register to be hired and converted to RCA. It took a TRC in my office 4 months after taking the test to get hired (and he still has not seen his form 50 showing he is a RCA). Encourage the TRCs to take that test now and once they are a RCA they can join the union.

Open Season: It is open season for RCA health insurance, 20-Year Term Life Insurance, Dental/Vision Insurance, Critical Illness, and Accident Insurance from March 1 through April 30th, available for all NRLCA RCA members. Start Early With The Retirement Process

Retirement is a goal that all workers strive for. I have just finished the retirement process. And yes it does feel good to have reached this goal. I just want to share some of my experience with the retirement process. There is a lot of paper work involved and it can be intimidating. I was able to find someone who was familiar with the paper work process. Being that Human Resources is not local it really saved me a lot of time and stress. These are some personal suggestions to prepare for retirement.

- 1. At least 18 months before you plan to retire, start getting information about the process. Check internet resources, HR and coworkers that have just retired or are in the process.
- 2. Ask HR, for a current estimated annuity. It will show you what info they have on you

marked by April 30, 2013 to qualify for guaranteed issue. You can also go to the NRLCA.org website to see the details.

Finances and Future: With the transition to the National Steward System (NSS) we will have to decide the direction/goals for the WARLCA in the upcoming years, now that the duty of fair representation is under the direction of the NRLCA, not the WARLCA. What can the WARLCA do to represent our members? It will be your input that decides. Many states will be dedicating their time to legislation as well as membership recruitment and informational meetings. Most of the dues will be going to National, but we still have the duties as outlined by our Constitution, such as paying delegates to National and State Convention. What do you want from your union? Let your officers know and/or attend your county and state convention with your ideas and suggestions.

for retirement purposes. This will help you to correct their records.

- 3. Also make copies of all your paper work that you send in to HR. Also make sure your EIN is on each item that you send in.
- 4. Send your paper work back by certified mail with return receipt.
- 5. If you have questions about the process always contact HR to get it right.

I hope that this will help you to have a smooth retirement process. And remember that this is my personal experience.

On a more personal note, I want to thank the State Board for all of their support these past two years. It has been an honor and privilege to work with such a dedicated board. They have worked hard to make sure that our State board meets the needs of our membership. With things changing as fast as they are, they continue to meet those challenges to keep our membership informed.

I also want to thank all of the District Three county officers and membership, for all their hard work and support to our Union and myself. You are the back bone of our Union and the Board thanks you for what you do each year.

How Many Rural Carriers Can Speak Fluent "Ruralese"

The other day, I got a phone call from a rural carrier. The carrier was upset because their day off had been changed. So, the first questions I ask are: "Is your office a formula office"? Huh...what's that? What is your evaluation? Are you a "H", a" J" or a "K"? What do you mean? It is like we are speaking a different language and really could not communicate.

I remember when I started my career, I knew very little, just that I wanted to be successful. It was because of some of the established regular carriers who "required" me to become knowledgeable about the work rules, to attend Union meetings and become involved that I was able to navigate the challenges of being a Rural Letter Carrier. They made it clear to

me that even though I did not know the rules, I would still be held responsible.

Ignorance is not an ex-

cuse. Hopefully you are in an office where the car-

riers make an effort to inform themselves about what our contractual rights and responsibilities are.

How about a quick quiz to determine how well you speak "ruralese"? See how many of the following you know:

What is a "H", "J" and "K" route?

- · What is my volume (box) factor?
- · What is my job designation?
- · What is a "L" route?
- · What is a Form 50?
- Management required me to work my relief day, how am I compensated?
- What is a 8127? When is it used?
- · Where is the list of proper mark-ups?
- · Which contractual article tells which relief gets to work when?
- Are RCAs paid by the evaluation or hourly?
- · What are Weingarten Rights?
- · What is a Free Saturday?

Did you know all the answers? Where could you find the answers? Most of the answers can be found at www.nrlca.org (our Union's national website). For example, let's take the question about what a Free Saturday is. Go to the website, login in and then go to the "Departments" tab. Hover on the "Steward Operations" tab and then click on "Reference Guide". Then click on the "Steward's Reference Guide A-Z", then "F", then scroll down and click on "Free Saturday". Several sources of information are available to you.

You would learn that "Free Saturday(s)" are given to regular rural carriers on "H" or "J" routes provided that:

- 1. They have put in for an entire week of Annual or Sick Leave. The week may include a holiday.
- 2. They have the leave balance to cover all of the days.

The carrier is charged for the leave Monday through Friday, but is not charged for the Saturday (s). If I were a Regular Rural Carrier serving an "H" or "J" route, you can be assured that I would have already checked out the Free Saturday provi-

sions so that I did not end up working for free. If I were a Rural Carrier Associate (RCA), I would be very interested in what the website has to say about my job (there are 64 different subjects concerning RCAs listed).

Because of the new National Steward program, we have some former Washington State Local Stewards that are now a part of the steward system in the Portland District. Unfortunately, they were omitted from the list of local stewards in the last paper. They are:

Please do not rely solely on your stewards or management to tell you what you should know, when you should know it. Your stewards work hard for you and will continue to represent you in the grievance process. Management is responsible for the business and may or may not know what the rules are. In the end, it is the responsibility of all of us to know what our rights and responsibilities are.

2013 National Delegate Ballot Timeline and Notification

Here is the timeline for those wishing to be on the ballot for 2013 National Convention.

- May 13, 2013: Nominations must be <u>received</u> by the State Secretary-Treasurer by mail. Any nominations received after this date will not be valid. Nomination forms can be found in the *National Rural Letter Carrier* magazine, in the February, March, April, and May issues. Nominations must be on this form (or a copy of this form). You can also find the *National Rural Letter Carrier* magazine on line at nrlca.org.
- May 14, 2013: A listing of members and labels will be printed from the NRLCA database to be used for the mailing of the ballots. Also a drawing of names for placement on the ballot will be held at 9 A.M. in the break room of the Greenacres Post Office, 306 N Barker, Greenacres, WA 99016. Two members whose names are not on the ballot will be doing the drawing. Candidates, or their designee, can observe this drawing.
- May 17-31, 2013: The ballots and ballot instructions will be printed by Staples. An independent contractor will pick up the ballots, ballot instructions, and envelopes. They will stuff and seal the ballots and mail them in their entirely at Spokane Valley Post Office, 11712 E Sprague, Spokane Valley, WA 99206.
- June 3, 2013: The ballot mailing must be completed by this date.
- June 11, 2013: Two members of the 2013 Tellers Committee, whose names are not on the ballot and have been appointed by the WARLCA President, will check the returned undeliverable ballots at the Oak Harbor Post Office. They will make a determination if a correct address can be found and resend the ballot again in a separate envelope.


